MEMORANDUM OF UNDERSTANDING

Between

Shri. Pancham Khemraj Mahavidyalaya, Sawantwadi

and

Sant Rawool Maharaj Mahavidyalaya, Kudal

Concerning the establishment of academic and collaborative programs

Introduction 1.

Shri. Pancham Khemraj Mahavidyalaya, Sawantwadi and Sant Rawool Maharaj Mahavidyalaya, Kudal has many areas of common interest. In some of these areas, the degree of mutual interest is such that the considerable advantages may be gained from their pursuit on a collaborative basis. Collaboration will be established within the principles set out in the following sections, which will be reviewed periodically. The MoU will be amended, if amicably agreed by both parties.

Purpose, Scope and General Policies 11.

A. Purpose

The purpose of this collaboration it to provide the academic and educational cooperation and to promote mutual understanding between the two colleges to stimulate the training of undergraduate and postgraduate students and faculties

B. Scope

The general area of interest of the collaboration will include all disciplines, more so at U.G and P.G. level and research which are of mutual interest with a focus on

- 1. Exchange of Faculty
- Exchange of students
- 3. On the Job Training of Undergraduate/Postgraduate students
- 4. Conducting collaborative research projects
- 5. Conducting lectures and organizing workshops, conferences
- Exchange of knowledge and literature.

Composition 111.

The collaboration involves two primary groups:

- 1. Regular faculty members and students of the Shri. Pancham Khemraj Mahavidyalaya, Sawantwadi.
- 2. Regular faculty members and students of Sant Rawool Maharaj Mahavidyalaya, Kudal.

Mutual and separate responsibilities of Shri. Pancham Khemraj Mahavidyalaya, Sawantwadi and Sant Rawool Maharaj Mahavidyalaya, Kudal. IV.

. A. Faculty, Staff and Students

- 1. Each of the participating institution is fully responsible financially and operationally
- 2. The costs of secretarial and clerical personnel, technician and other scientific support personnel will be borne by the person concerned or employer of such personnel

- 1. Working space and infrastructure required for the project will be provided by B. Space and Facilities
 - 2. Joint use of each other's equipment and facilities as long as such cooperative use does not disturb the normal programs of either party.
 - 3. Any damage or loss to property will be borne by the personnel responsible or their employer.

C. Ownership of Intellectual Properties

The collaborative research activities under the MoU, if results in any potential for intellectual property, both organizations shall seek an equitable and fair ownership and other property interests.

D. Amendment and Termination of MoU

- 1. This MoU may be amended or modified by a mutual written agreement signed by the representatives of both the Institutions.
- 2. This MoU will come in force from the date of signing by representatives of both the institutes. This MoU shall be renewed after being reviewed and renegotiated by
- 3. This MoU may be terminated at will of anyone or both the parties upon prior notice to the other in writing by the representatives of respective institute.
